While thanking you for being kind enough to respond to several leaders of AIUBRF, ABREA and CBRA by email, clarifying your view, in response to their emails/WhatsApp messages, we appreciate your first such communication.

We invite the initiative of the bank for setting up of Portal to address retiree related individual issues online. However, may we respectfully state that the Portal has limited functionality confined to five areas of individual grievances of retirees only?

Many of the pertinent issues of the retirees such as UBIREMAS, Union Parivar, Holiday Homes, Implementation of Best HR practices as envisaged at the time of amalgamation, Discrepancies in payment of 11<sup>th</sup> Bipartite arrears viz., salary, leave encashment, Medical aid, Gratuity, Commutation, Stagnation increments; updation of retirees records etc., are away from the purview of the Portal. We wish to inform that the present Portal acts as supplementary and not a substitute to resolve the ongoing retiree's issues.

Thus, once again, we earnestly request the Bank to convene a Grievance Redressal Meetings, which paves the way to strengthen our relations further and enable us to address the retiree related issues smoothly and amicably.
