Terms and Conditions:

This Health Check-up Package rates will be valid from 23rd March 2022 to 31st March 2023.

1. The employee should submit **Union Bank ID card** and employee dependents should submit a copy of **employee's Union Bank ID card** and any government ID Proof (Aadhar card) which establishes the relationship with the Employee.
2. The above mentioned packages can be availed on **payment basis** for Employees, Retirees and their Dependents.
3. **Definition of Dependents** - Employee's Spouse, Kid/s, Mother and/or Father
4. **Reports delivery:** Reports will be generated maximum of 24 hours of investigations for routine tests. For special/outsourced tests it may take **3 working days**.
5. **Reporting:** Reports of all diagnostic tests conducted on client/customer under this tie-up will be handed over the employee/ dependent whoever is undergoing Health Check.
6. **Termination:** Both the parties have right to terminate this contract by giving 30 days' notice in writing without assailing any reasons. In case of termination, you agree to clear all dues immediately if any, at the time of such termination.
7. **Governing Law and Jurisdiction:** Any dispute arising out of this agreement shall be subjected to the laws of India for the time being in force and only the courts at **Hyderabad** shall have exclusive jurisdiction.



Dos and DONTs for Medical Check-up

1. All Health Check-ups are conducted by **prior appointments only**.
2. You should intimate at least 24 hours prior to your visit.
3. You are requested to reach between 7:00 am - 08:00 am or at a given time to facilitate the smooth process of your health check-up.
4. Minimum of 12 hour fasting is essential prior to the health check-up.
5. You may drink water during fasting period. Refrain from drinking alcohol at least 12 hours prior to the health check-up.
6. Men are required to shave their chest for 2D-Echo / Tread Mill Test.
7. If you wear contact lenses, please remove those 2 days prior to your health check-up
8. Wear loose clothing, no jewelry (Necklaces / Chains) and easily removable footwear.
9. If you are diabetic, avoid taking your insulin injections / anti diabetic tablets on the morning of health check-up. Please, carry your insulin injections / anti diabetic tablets which you can have before or after your breakfast at the Centre. Other regular medication can be taken as instructed by the doctor. Please carry regular medication along with you.
10. Please bring all your earlier (within a year) medical records and medical accessories like spectacles/hearing aids when you come for health check-up
11. Additional tests / investigations / procedures / consultations on request or if required may be provided. However, these will be billed separately in addition to the package cost.
12. Please be informed that certain tests like X-Ray are not to be done if you are pregnant.
13. For women, it is not advised to undergo Health Checks at the time of menstrual cycle.

The list of branches in Hyderabad/ Secunderabad wherein the employees, retirees and their dependents may avail the benefits of this scheme are enclosed as an Annexure to this Circular. All the contents of this Circular may be brought to the notice of all staff members including the retired staff members, to avail the benefits of this tie-up arrangement and discounted health check-up schemes.
